With our Only Representative ("OR") service you get easy access to the European market for your chemicals

Compliance with the REACH regulation is mandatory for any company wanting to place chemical substances on the European Union (EU) and European Economic Area (EEA) market. Companies located outside the EU/EEA need to appoint an Only Representative (OR) in the EU/EEA to be able to REACH register their substances.

WHAT IS AN ONLY REPRESENTATIVE?

Under the REACH Regulation, a company established outside the European Union (EU) and the European Economic Area (EEA), that manufactures a substance, formulates a mixture or produces an article, can appoint an Only Representative to carry out the required REACH registration and other REACH compliance task for the substance (as such, in a mixture or in an article) that is imported into the EU/EEA. Having an Only Representative relieves EU/EEA companies importing the substance, within the same supply chain, from any registration obligations, as they will be regarded as downstream users according to the requirements of the REACH Regulation.

We act as their OR carrying out all the registration work needed to successfully submit the dossier to ECHA.
