

How the inclusion of your substances in the India BIS list may affect your business in the Indian market?

1. All substances included in the India BIS list are required to obtain India BIS Licence

2. Upon inclusion of your substance(s) in the India BIS list you will have only 180 days from the date of your substance's inclusion in the list to obtain such licence

3. Companies that are not compliant with India BIS requirement are subject to fines and their supply to India will be disrupted

The BIS Act, 2016, Rules & Regulations is a means for providing a third-party guarantee of quality, safety, and reliability of products to the customer. Under BIS Act 2016, BIS Rules 2018 and BIS (Conformity Assessment) Regulations 2018, the provisions for Grant of Licence (GoL) are addressed. It covers BIS Licence for both Domestic and Foreign manufactures for chemical products listed in Scheme I (India BIS list) that are placed on the Indian market. India BIS Licence must be obtained within 180 days from the date of inclusion of such chemicals in Scheme I as defined in Quality Control Orders (QCO(s)).

#### India BIS application process is:

- Complex and time consuming
- It has a tight deadline for preparation, submission, BIS Inspector factory visits, etc – 180 days
- Implementing BIS Standard Mark on your products
- It requires a lot of communication with the Indian Authorities
